On October 1, 2018, FINRA restructured the testing for its securities series licenses (Series 6, 7, 22, 57, 79, 82, 86/87 and 99). The new Securities Industry Essentials (SIE) Exam allows prospective industry professionals to take the introductory level exam without being sponsored by an industry member firm. The multiple-choice exam is 75 questions and 105 minutes in length that is comprised of four sections including knowledge of capital markets, understanding products and their risks, understanding trading, customer accounts and prohibited activities and overview of regulatory framework.

Shareholder Activism

An activist shareholder is a shareholder that uses an equity stake in a corporation to put pressure on its management. Shareholders can use their ownership positions to drive change by issuing formal proposals, which are voted on by all shareholders at a company's annual meeting to alter policies or by gathering shareholder proxy votes in an attempt to replace board members. Institutional investors and hedge funds have the most impact in driving change, while individual shareholders typically lack sufficient capital.

Shareholder activism is booming in 2018. This might be due to the increase in M&A activity this year. Activists are influencing transactions by ensuring the deal process is even handed for both the buyer and seller. According to a Columbia Business School research study M&A deals in 2018 that were challenged by activists only had a completion rate of 54.0% and M&A deals without activists had a completion rate of 91.0%.

Recently, Vintage Capital Management purchased a 14.9% stake in Babcock & Wilcox to push for a proxy battle for control of the board. One of the many consequences is that B&W is moving its HQ from Charlotte, NC to Barberton, OH.
